### 3.) OLD BUSINESS

Recap of September presentation

- Merits of asking township to adopt Ready for 100 resolution were discussed; group reached consensus that any presentation to supervisors should include information on:
  - Steps to begin implementation of energy conservation strategies
  - o Financial benefits and costs
- We will focus on reviewing ordinances that relate not only to energy conservation, but other township priorities such as stormwater management over the next two months
- Jackie will prepare a matrix of ecosystem services and ordinances to serve as a framework for our review in November

## **EAC Ordinance**

- Revised ordinance allows us to self-organize
  - o Rachel will remain in chair position
  - Rachel moved to accept Jackie's resignation as secretary, Ruth seconded; motion approved unanimously
  - Ruth moved to accept Denise's self-nomination for secretary, Jackie seconded; motion approved unanimously
- Ruth will contact Mark regarding draft by-laws and revise as needed

#### Outreach

- Rachel will lead organization of stormwater presentation by the Montgomery County Conservation District (MCCD) geared toward homeowners
  - We will share information with neighboring townships and other townships in the regional planning district
  - Targeting winter (January/February) presentation

- Additional outreach approaches were discussed including participation at township/community events (i.e. a table with materials/demonstration), coordination of volunteer programs (e.g., tree planting, park clean-up); we will assess outreach strategies following stormwater presentation
- Ruth provided summary of the township's 2019 MS4 Annual Status Report
  - o Report cites EAC as providing outreach
  - MS4 outreach should address impaired waterways; Perkiomen Creek is nutrient and oxygen impaired, Swamp Creek is impaired by sediment
