INSTRUCTIONS FOR OBTAINING A USE AND OCCUPANCY PERMIT

For Resale of Single- or Two-Family Unit Dwelling

- 1. Complete and notarize the attached Affidavit.
- 2. If the property is connected to Lower Frederick public sewer, call 610-287-6658 to schedule an appointment with the Sewage Inspection Officer. This inspection should be completed prior to notarizing the Affidavit.

If the property is connected to Schwenksville Borough Sewer, a copy of the Private Sewer Lateral Inspection report by the Schwenksville Borough Authority must be on file at the Lower Frederick Township office.

- 3. If the property has an on-lot system, the system should have been pumped and inspected within the last 3 years to be in compliance with the Township Ordinance. A copy of the most recent inspection report is on file at the Township Office.
- 4. The Use and Occupancy Permit will be issued only upon receipt of the ORIGINAL notarized Affidavit.
- 5. Use and Occupancy Permit fee is \$25 and due when Affidavit is received. Please make check payable to "Lower Frederick Township"
